The deadline for submitting proposed names is December 30, 2011, at 4:00 p.m.; entries must be delivered to 515 Spring Street, Paso Robles, CA. No entries submitted thereafter will be considered. There is no limit on the number of people (Contestants) who may submit proposed names, nor is there a limit on the number of proposed names that will be considered. Contestants may propose up to three names per entry.

On January 1, 2012, Richard Rossi will solely decide which proposed name is the winning name and the winner's name, which will then be announced on our website, www.sanluisobispoattorney.com. Richard Rossi reserves the right to poll the public re the best name. Some names will be proposed by more than one Contestant, in which event the first person to propose the winning name will win.
